

## **Conditions of Use, Copyright and Disclaimer**

### **Conditions of Use**

The Oregon Institute of Technology Libraries have created their Digital Collections as part of their educational and scholarly mission. The materials in these collections are available for use in research, teaching, and private study, but may not be used for any commercial purpose.

### **Copyright**

Some materials in the collection may be protected by the [U.S. Copyright Law](#) (Title 17, United States Code) and/or by the copyright laws of other countries. For materials not in the [public domain](#), the Library has sought permissions from the authors to scan and mount those materials for the public view.

### **Reproduction of Materials**

The U.S. Copyright Law governs the making of photocopies or other reproductions of copyrighted material. Under [certain conditions](#) specified in the Law (§108), libraries and archives are authorized to make photocopies or other reproductions for their users.

However, the Libraries reserve the right to refuse to accept a copying order if, in its judgment, fulfillment of the order might violate the copyright law.

Digital Collections users are ultimately responsible for determining copyright restrictions, for obtaining written permission from the creators of the materials, and for paying any fees necessary for the reproduction or proposed use of the materials.

### **Attribution**

The Libraries ask their users to give proper attribution of the materials.

### **Disclaimer**

The Libraries will not be held responsible for any direct, indirect, consequential, or incidental damages arising out of or relating to the use of the information and materials linked to or found in its Digital Collections. Use of the information is the sole responsibility of the user.

If a copyright holder believes that a document or a photograph of which they were the creator or the subject, was published in the Libraries Digital Collections without their permission, and that the inclusion of this material in the Libraries Digital Collections

infringes their rights or violates their privacy, they or their agents may contact the Libraries at [libtech@oit.edu](mailto:libtech@oit.edu).

Any claim of possible infringement must fulfill the requirements specified in Title II of the [Digital Millennium Copyright Act](#) of 1998. All infringement claims must be in writing and include the following information:

- Description and identification of the material claimed to have been infringed with the information reasonably sufficient to permit the Libraries to locate the material (preferably an exact URL)
- Contact information for the copyright owner or authorized agent, including address, telephone number, and email
- Statement by the copyright owner or their agent of the reason why they believe that their rights or privacy have been violated, with any pertinent documentation

The Libraries will acknowledge the claim in a timely manner, and will assess its validity. Upon completion of the assessment, the Libraries will take appropriate action and communicate that action to the claimant.

The Libraries may work with the Oregon Institute of Technology Legal Liaison and with the Risk Officer to make a determination.
