

## REQUEST FOR TUITION EQUITY AN EXEMPTION FROM NONRESIDENT TUITION AND FEES (H.B. 2787)

ORS 352.287 (otherwise known as the Oregon Tuition Equity Act) allows students who are not citizens or lawful permanent residents of the United States to pay resident tuition and fees at an Oregon public university under certain conditions. This form is used to determine if a student applicant meets those conditions. Exemptions are granted for a maximum of five years from the date of initial enrollment at an Oregon public university. This form must be submitted to the Office of Admissions by the first day of the term in which classification is sought. Tuition adjustments will not be granted retroactively for previous terms. With the passage of SB 1563 in 2018, applicants are no longer required to submit an affidavit stating that the student has applied for taxpayer identification or immigration documents.
